INFORMED CONSENT AND RELEASE OF LIABILITY

I acknowledge that the athletic activities of camp will be an extreme test of a person's physical and mental limits and carries with it the potential for death, serious injury and property loss. The risks include, but are not limited to, those caused by terrain, facilities, temperature, weather, condition of athletes, equipment, vehicular traffic, actions of other people including, but not limited to, participants, volunteers, spectators, coaches, and lack of hydration. These risks are not only inherent to athletics, but are also present for volunteers. I hereby assume all of the risks of participating and/or volunteering in this event. I realize that liability may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained or controlled by them or because of their possible liability without fault. I certify that I am physically fit, have sufficiently trained for participation in the camp and have not been advised otherwise by a qualified medical person. I understand that I will be held to camper guidelines and agree to abide by such expectations. I understand that a breach of these guidelines and expectations could result in dismissal from camp.

- (1) Campers may not change rooms without notifying and being granted permission by the Camp Director
- (2) Campers must always be appropriately dressed while in communal areas or open spaces.
- (3) Campers should never walk anywhere on campus alone, and must keep to areas and pathways pointed out by the Camp Director. Campers should always be in a group when walking on permissible pathways. It is recommended that they be in groups of four or more.
- (4) Campers may not enter another camper's room without permission.
- (5) Campers are not permitted to leave campus unless the Camp Director has given prior permission after speaking with the camper's parent(s) or guardian. A camper who leaves camp (i.e. the dorms, the fields) without permission can be sent home immediately.
- (6) Campers should be in their own dorm room at "lights out"/"bed check" as deemed by the Camp Director.
- (7) Campers may not degrade, abuse, haze, or harm any of their fellow campers. Campers should treat one another with respect.
- (8) Campers should look out for themselves and each other, and talk to the Camp Director or a staff member if they have been hurt, harassed, are worried about another camper, or have any other concerns.

I acknowledge that this Accident Waiver and Release of Liability form will be used by the camp staff in which I may participate, and that it will govern my actions and responsibilities at said events.

In consideration of my application and permitting me to participate in this event, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows: (A) Waive, Release and Discharge from any and all liability for my death, disability, personal injury, property damage, property theft or actions of any kind which may hereafter occur to me including my traveling to and from this event, **THE FOLLOWING ENTITIES OR PERSONS: Colonial Kicks Soccer Camp, including the Director, camp employees, volunteers and any and all persons associated with the operation of the Colonial Kicks Soccer Camp.**

The Camp Director and Staff; (B) Indemnify and Hold Harmless the entities or persons mentioned in this paragraph from any and all liabilities or claims made as a result of participation in this event, whether caused by the negligence of releases or otherwise.

I hereby consent to receive medical treatment that may be deemed advisable in the event of injury, accident and/or illness during this event.

I understand that at this camp or related activities, I may be photographed. I agree to allow my photo, video or film likeness to be used for any legitimate purpose by the event holders, producers, sponsors, organizers and assigns.

The Accident Waiver and Release of Liability shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.
